RELEASE OF SECURITY INTEREST IN PATENT RIGHTS

This RELEASE OF SECURITY INTEREST IN PATENT RIGHTS, (this "Release"), dated as of December 24, 2019, is made by BARCLAYS BANK PLC, as collateral agent (in such capacity, the "Collateral Agent") for the benefit of the Secured Parties, in favor of WEBROOT INC. (the "Grantor"). Capitalized terms used and not defined herein have the meanings given such terms in the Security Agreement (as defined below).

WHEREAS, pursuant to that certain Security Agreement, dated as of March 26, 2019, among the Grantor, any Subsidiaries that became a party thereto, and the Collateral Agent (as may have been amended, restated, supplemented and/or otherwise modified from time to time, the "Security Agreement"), the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in, all of its right title and interest in, to and under certain Intellectual Property, including the Patent Collateral (as defined below);

WHEREAS, pursuant to the Security Agreement, the Grantor executed and delivered to the Collateral Agent a Grant of Security Interest in Patent Rights, dated as of March 26, 2019 (the "Patent Security Agreement"), pursuant to which the Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in all of the Grantor's right, title and interest in, to and under the Patents that are not Excluded Property (including, without limitation, those Patents listed on Schedule A hereto), together with all rights, priorities, and privileges related thereto and all rights to sue or otherwise recover at law or in equity for any infringement or other violation or impairment thereof, including the right to receive all Proceeds therefrom (collectively, the "Patent Collateral");

WHEREAS, the Patent Security Agreement was recorded in the United States Patent and Trademark Office on March 28, 2019, at Reel/Frame 048723/0612; and

WHEREAS, the Collateral Agent, on behalf of the Secured Parties, wishes to release its security interest in the Patent Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

The Collateral Agent hereby absolutely, unconditionally, irrevocably and forever: (a) terminates the Patent Security Agreement, and (b) releases, discharges, terminates and cancels its lien on and security interest in the Patent Collateral, in each case without any recourse to the Collateral Agent (whether as the Collateral Agent or in its personal capacity) and without any statement, representation, warranty, promise or undertaking whatsoever by the Collateral Agent (whether as Collateral Agent or in its personal capacity). The Collateral Agent, on behalf of itself and the Secured Parties, authorizes and requests that the Register of Patents and any other applicable government officer record this Release.
